## "Unlimited Club AUX Virtual Meet & Greet Sweepstakes"

## **OFFICIAL RULES**

## NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCES OF WINNING.

**DATES OF SWEEPSTAKES:** The "Unlimited Club AUX Virtual Meet & Greet Sweepstakes" (the "Sweepstakes") begins at 3:00 P.M. Pacific Standard Time ("PST") on Thursday, June 20, 2024 and ends at 6:59 P.M. PST on Thursday, June 20, 2024 (the "Sweepstakes Period").
