## "Unlimited Club LAX Virtual Kickoff Sweepstakes"

## **OFFICIAL RULES**

## NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCES OF WINNING.

**DATES OF SWEEPSTAKES:** The "Unlimited Club LAX Virtual Kickoff Sweepstakes" (the "Sweepstakes") begins at 3:00 P.M. Pacific Standard Time ("PST") on Friday, July 26, 2024 and ends at 6:59 P.M. PST on Friday, July 26, 2024 (the "Sweepstakes Period").

**ELIGIBILITY:** The Sweepstakes is open only to persons who are a legal resident residing in the forty-eight (48) contiguous United States or District of Columbia and are eighteen (18) years of age or older at time of entry (the "Entrant").
